The Mountain Express offers a deviated fixed route service to the citizens of Allegheny County, Clifton Forge, Iron Gate, and Covington. [The route map and schedules](#) are available for download on the website.

A fare of \$1.00 per trip is charged and must be paid when boarding the van. An exact change is required. Children under the age of six years old ride at no charge.

Individuals who are Americans with Disabilities Act (ADA) certified may request the van to deviate off its route to make pick-ups and drop-offs. This distance may not exceed 3/4 of a mile off the route. All ADA-deviated rides must be scheduled at least 24 hours in advance. Drivers are trained in passenger assistance, defensive driving, cardiopulmonary resuscitation, and wheelchair securement procedures.
