Virginia State Parks strive to make each park as barrier-free as possible for the convenience of those with limited mobility. Each <u>park page</u> on this site has information on the availability of facilities for people with disabilities. Please check back often as we are updating these pages, working to provide more comprehensive information on specific facility and service availability. Personal Mobility on Trails

The Commonwealth of Virginia's natural area preserves, state forests, state parks and wildlife management areas offer hundreds of miles of trails designed for people to enjoy (or access) the outdoors. These trails offer the public opportunities to experience and enjoy the state's flora, fauna, cultural resources and scenic beauty.

Parks with accessible trails include <u>Bear Creek Lake</u>, <u>Belle Isle</u>, <u>Chippokes</u>, <u>Claytor</u> <u>Lake</u>, <u>First Landing</u>, <u>James River</u>, <u>Kiptopeke</u>, <u>Lake Anna</u>, <u>Leesylvania</u>, <u>Mason Neck</u>, <u>Southwest Virginia Museum</u>, <u>Natural Tunnel</u>, <u>New River Trail</u>, <u>Pocahontas</u>, <u>Machicomoco and Westmoreland</u>.

Many trails are open to wheelchairs, including manual and power wheelchairs, personal mobility assistive scooters and certain other similar devices designed primarily to assist people with disabilities. Users are encouraged to use caution when selecting trails, as many were designed for foot traffic only. Terrain might make them unsuitable for personal mobility devices.
